On 03/28/17, I spoke with Shirley Pantaleon-Nunez, 9862 Moss Rose Way, Orlando, FL. Nuzez said that she has been receiving text messages from a person name Lenny Pozner.

She also said that Lenny has even been exploiting her 11 yr old domains that he owns. online, and has put her onto over 20

I advised Nunes that I reviewed the attachments that she submitted, but they only revealed pictures of her brother, Felix, who lives in New York, and some blogger in California.

Nunez was not satisfied with my response and ask that her report be sent to a detective.

On 04/05/2017 I was assigned this case to follow up. The initial report was taken by BRPD Community Service Officer Joe Cortez on 04/04/2017 when the complainant, Shirley Pantaleon, called from Orlando, Florida. Shirley wanted to report that 11 year old picture was posted on line by Lenny Pozner of Boca Raton, Florida. The image was of Shirley and standing in a shopping mall and was taken most likely from a Facebook posting. Shirley felt that this was an exploitation of and requested a detective be assigned to follow up on her report. It should be noted that a Cybertip Report was also made in reference to this incident via the National Center for Missing and Exploited Children by Shirley's brother Felix Pantaleon on 03/27/2017 (Cybertipline Report # 19505500). I also received that complaint through the Broward Sheriff's Office Internet Crimes Against Children Task Force NCMEC.

On 04/05/2017 I spoke to Shirley over the phone and advised her that the picture of taken from the internet did not fit the criteria to be classified as a image depicting the exploitation of a child as it pertained to the Internet Crimes Against Children Task Force. I explained to Shirley that the images that were illegal were the ones depicting the sexual exploitation of children. In her case, Shirley's was only standing in a family photo and depicted nothing of a sexually explicit nature. Shirley advised that she did not understand that and further stated that she was afraid of the man who may have had something to do with posting the image, Lenny Pozner. Shirley explained that her brother, Felix Pantaleon (the one who made the NCMEC report) had been involved in an on-going argument on-line with Lenny about the Sandy Hook School Shooting Incident on December 14th, 2012. Felix, according to Shirley, does not believe the incident occurred and regularly speaks out against it and Lenny Pozner on the internet. It wasn't until recently that Shirley did not concern herself with Felix's posts except she became upset when someone posted picture online. Shirley stated that she wanted to be left out of the argument between her brother and Lenny. I told Shirley that I would be following up with Lenny about the post.

On 04/05/2017 I also received an email from Sgt. James Duke with the New York City Internet Crimes Against Children Task Force about Felix's Cybertip Report mentioned in the first paragraph. Sgt. Duke requested that I contact him with any information I may have in regards to this case.

On 04/05/2017 I spoke to Lenny Pozner about this case. Lenny stated he did not post the image of Shirley's. Lenny further stated that he felt Felix was harassing him as there were numerous postings that Felix had made in the past accusing Lenny of being a "child molester". Lenny said that this was all untrue and that Felix was doing this to get back at him for their argument about the Sandy Hook Incident. Lenny stated that his son Noah was killed in the incident and that people like Felix have no right to say the incident never occurred. Lenny told me that Felix has posted videos showing the location of his apartment building in Boca Raton on Youtube.com. Lenny also stated that Felix sent an email to his building manager requesting Lenny's exact apartment number so that he may get a warrant

for Lenny because he exploits children on-line. Lenny provided me with multiple links to websites that Felix maintained regarding Lenny and the Sandy Hook Incident being false. Most of the links were linked to Google Plus which is a Google social networking platform. I told Lenny that Shirley had reported a separate report from the NCMEC report that Felix made. I further advised Lenny that I explained to Shirley that there was no crime of child exploitation as a result of the post. Lenny asked me if Shirley could be charged with filing a false police report and I said no. Lenny requested to have a copy of the report and I told him that once this case was closed he could obtain it from the front desk of the police department. Lenny asked if he could post the report on the internet and I advised him as long as my investigation was complete, the report was classified as public record. I further suggested to Lenny that if he felt he was being harassed by Felix then he could make a report with the New York Police Department. I also told Lenny that I would send Sgt. Duke his contact information and request he contact him reference Felix. Finally, I suggested that Lenny stop his on-line argument with Felix as it may lead to undesirable results in the future. I told Lenny that most of what was being posted was not a crime since the internet is largely unregulated and most of what is posted is covered under the right to free speech. As an alternative to arguing on line I told Lenny to focus his efforts on the members of his foundation the Honr Network (www.honr.com) which he set up for families who have lost loved ones to violent deaths such as the Sandy Hook Incident. Lenny thanked me for my time and ended the conversation.

On 04/18/2017 I sent Sgt. Duke of the NYPD an email explaining the outcome of my conversations with Lenny and Shirley. I forwarded Lenny's contact information to Sgt. Duke as I mentioned to Lenny in our conversation. Sgt. Duke replied and said he would follow up.

On 04/20/2017 I received an email from Shirley Pantaleon stating that someone posted her picture from her LinkedIn page on 7 websites with the caption " Shirley Pantaleon of Orlando Florida targets parent of a child killed at the Sandy Hook School Shooting with an unfounded CPS Report." and "Hoaxer Shirley Pantaleon of Orlando Florida files a fraudulent report targeting the parent of a victim of a violent crime. (The Sandy Hook School Shooting - Who does that?) Case BRPD 2017-4968 (Will be posting full report here)". Shirley sent 7 links to 7 web sites that listed her picture and the aforementioned words.

I spoke to Shirley over the phone and she was irate and very upset over the posts. Shirley stated that she did not want to be involved in what was going on between her brother Felix and Lenny. I asked Shirley how she found out about the websites and she said her brother Felix sent them to her.

On 04/20/2017 I called and spoke to Lenny Pozner. I asked Lenny if he created the 7 web sites with Shirley's name and picture as mentioned in the previous paragraph and he said yes he did post them. I explained to Lenny that the websites he made were specifically directed at Shirley Pantaleon and they were communicated electronically to her

which caused her apparent distress. I told Lenny that since he was located in the City of Boca Raton, my jurisdiction, he could be subject to criminal charges pursuant to Florida State Statute 784.048(d)(3). I warned Lenny that anymore posts regarding Shirley would show a course of conduct aimed at causing distress and could result in his arrest for violating the aforementioned statute. Lenny asked if he could still post about Felix and I told him that I wasn't going to give him permission to do anything and that he would be responsible for his actions in the future. Lenny advised he would remove the websites pertaining to Shirley and ended the conversation.

A check of the 7 previously mentioned websites indicated that they were removed and no longer accessible. As of this time I recommend this case be classified as unfounded as the original complaint that the daughter of Shirley Pantaleon was being exploited on-line was false. As mentioned previously, the online exploitation of children pertains to the trading or manufacturing of actual children or images depicting the sexual abuse of children. The image in this case did not fit that criteria and therefore no crime has occurred at this time based on the facts discovered in this investigation.
